

HIŠNI RED CAMPA DANICA

Spoštovani gosti, dobrodošli v našem campu.

Veselimo se Vašega obiska. Celotno osebje campa se po najboljših močeh trudi, da bi bilo Vaše bivanje pri nas čim lepše. Da pa je Vaše bivanje lahko tudi brezskrbno, Vas naprošamo, da spoštujete naslednja pravila hišnega reda:

1) PRIJAVA GOSTA JE OBVEZNA:

Prosimo vas, da se takoj po prihodu v camp s svojim **osebnim dokumentom** (osebna izkaznica ali potni list) prijavite na recepciji campa. Za šotor, avtodom ali prikolico prevzame gost campa **tablico s številko**, ki jo je dolžan imeti na vidnem mestu vse do odhoda in jo ob odhodu tudi vrniti na recepcijo. **PRIJAVE GOSTOV SE OPRAVLJAJO OD 8.URE DALJE.**

Osebe, ki bodo zalotene v campu brez prijave, ravnajo v nasprotju s hišnim redom in bodo odstranjene iz campa ter prijavljene pristojnim organom zaradi eventualne storitve prekrška zoper javni red in mir, motenja posesti, izogibanja plačilu turistične takse v primeru nočitve v campu, izogibanja plačilu storitev campa, oziroma goljufije. V primeru, da se gost ne prijavi takoj pri prihodu ali v primeru, da pri prijavi gost ni posredoval točnih podatkov o številu oseb in opremi, bomo prisiljeni zaračunati stroške v višini **tridnevnega bivanja** neprijavljenih oseb in opreme.

2) ODJAVA GOSTA

Na dan odhoda se je gost dolžan odjaviti najkasneje do 13.00 ure, v nasprotnem primeru se gostu obračuna še ena nočitev. Gost lahko plača bivanje, storitve in turistično pristojbino tudi dan pred odhodom po 15.00 uri. Za plačane storitve gost dobi račun.

3) UPORABA PROSTORA ZA CAMPIRANJE

Na **neparceliranem** delu kampa, je izbira mesta v kampu prosta ob obveznosti racionalne uporabe prostora, upoštevajoč prostor Vaših sosedov.

Na **parceliranem delu kampa mora gost iti na mesto v campu, ki mu ga določa tablica**, pri tem pa mu pomaga osebje campa. Na vsaki parceli lahko gost postavi samo eno prikolico ali avtodom ali šotor in eno prevozno sredstvo (avto ali motor). Dodatno prevozno sredstvo se postavi na parkirišče v campu. Premična vozila za nočitev (avtodom ali prikolica) imajo lahko pred-šotore, če so naslonjeni na krov vozila in ne smejo štrleti zunaj le-teh. **Sprememba izbranega mesta je mogoča samo izjemoma** in to samo zaradi opravičenega razloga in ob dovoljenju pristojne osebe campa. V campu je prepovedano sprejemati obiske neznanih oseb brez dovoljenja recepcije. Uprava campa ima pravico dovoliti vhod obiskovalcem, sprehajalcem in jim izdati brezplačno kratkočasno dovoljenje. Prepovedano je omejiti prostor na način, da je onemogočeno prosto gibanje. Strogo je prepovedano parkiranje vozil na dovoznih cestah in poteh ali začasno zavzemanje drugih parcel ali mest, čeprav so prosta. V nasprotnem primeru bodo morali gostje plačati dodatno ceno za zasedeno mesto.

4) UPORABA NAPRAV IN OPREME

Gosti campa so dolžni pravilno uporabljati električne in komunalne naprave ter opremo. **Priključitve in izključitve električne energije opravljajo gostje sami, uporabo le-teh so dolžni prijaviti ob prihodu na recepciji.** Kontrolo varnosti električnih instalacij opravlja za to odgovoren delavec. Moč električne energije je 16 in 12 A, vtičnice so standardne.

Pomivanje posode in perila je dovoljeno v za to namenjenih prostorih. Pranje avtomobilov je dovoljeno na za to določenem mestu.

5) ZAŠČITA OKOLJA

Gosti campa so dolžni vzdrževati red in čistočo na prostoru, kjer campirajo, varovati nasade in zelenje, prepovedano je ograjevanje prostora ali katera koli gradbeniška dela na izbranem prostoru. Prepovedano je lomljenje, sekanje ali poškodovanje rastlinja (zabijanje žebeljev, vezanje vrvic in podobno na drevesa). Prepovedano je izlivi olje, gorivo, kipečo, slano in odpadno tekočino, kopati kanale in luknje na zemljišču, nekontrolirano izlivi vodo, puščati smeti zunaj obstoječih kontejnerjev. Za praznjenje kemičnega stranišča je določeno mesto v campu. Smeti se zbirajo ločeno (plastika, papir, steklenice, ostali odpadki), odlagajo se v ustrezne kontejnerje za ločevanje odpadkov. **Pustite uporabljene prostore v sanitarnih blokih takšne, kakršne bi želeli najti. Goste campa naprošamo, naj varčujejo z vodo.**

6) JAVNI RED IN MIR V CAMPU

Nočni mir v campu traja od 23.00 do 7.00 ure (petki in sobote od 01 do 07h). V tem času ni dovoljeno gibanje z motornimi vozili, ukvarjanje s športom in rekreacijo, montiranje in demontiranje šotorov, uporaba radio naprave, televizorja in glasbenih instrumentov. Z neupoštevanjem te točke reda se odvzame možnost nadaljnega bivanja v kampu.

Za vsa vozila je omejena hitrost znotraj campa 10 km/h. Pešci v kampu imajo prednost v primerjavi s prometnimi vozili.

7) OTROCI

Odrasli gostje campa so odgovorni za obnašanje svojih otrok, ohranjanje miru in morajo otroke nenehno nadzirati. Obvezni so plačati škodo, ki jo povzroči mladoletna oseba. Otroško igrišče uporabljate na lastno odgovornost.

8) ŽIVALI

Živali so v campu dovoljene, vendar ne smejo vznemirjati ostalih gostov campa. Lastniki psov so dolžni pse voditi na vrvi, na svojem prostoru pa jih držati vezane. Potrebo, ki jo opravijo hišni ljubimci, je lastnik dolžen počistiti. Neupoštevanje te točke podlega denarnim sankcijam.

Dostop jim ni dovoljen v toaletne prostore, na otroško igrišče in ostale športne objekte (to se ne nanaša na pse vodnike slepih oseb). Lastnik je odgovoren za vso škodo, ki jo povzroči njegov pes.

9) POŽARNA VARNOST

Kurjenje ognja na prostem, prinašati lahko zažigajočih goriv, eksplozivnih naprav in podobno je zaradi nevarnosti pred požarom z zakonom prepovedano. V primeru izbruha požara v campu ali njegovi neposredni bližini ima gost obveznost pristopiti k organiziranemu gašenju.

10) OSTALO

Za svoje imetje in stvari v campu je gost odgovoren sam. Uprava campa za gostove stvari ob izgubi, kraji ali poškodbi, ne odgovarja. Prav tako ne odgovarja za poškodbe in nesreče gosta v campu zaradi njegove nepazljivosti. Predmeti, ki so najdeni v campu, se morajo izročiti recepciji zaradi vrnitve ugotovljenemu lastniku.

Knjiga pritožb in pohval se nahaja na recepciji.

Gostom, ki se ne držijo tega Hišnega reda, kot tudi gostom, ki s svojim vedenjem motijo tišino in vznemirjajo druge goste, bo preklicana uporaba namestitvenih storitev.

CODE OF CONDUCT IN THE CAMPSITE

Dear guests, welcome to our camp.

We are pleased that you decided to visit our camp. For you to have a most enjoyable stay, our staff is here to service you to the best of their abilities. To enjoy a carefree stay at the Bohinj kamp Danica, follow these camp rules:

GUEST CHECK-IN

Only guests registered at the reception can be accommodated in the campsite. When you arrive to the camp, please, check-in at the camp reception area immediately and turn over your personal documents (a passport or I.D. card).

For your tent, camper van or caravan (trailer tent) you get a number plate, which has to be properly displayed till your departure. A monetary compensation will be charged if you lose it.

Every registered guest gets a pass. Anyone who is seen without one will have to leave the camp and be reported to proper authorities due to possible disturbing the public order and peace, trespassing, avoiding paying a tourist tax in case of an overnight stay, avoiding paying camp services or committing a fraud, which are all violations of the camp rules.

If you don't check-in immediately upon your arrival, or you failed to provide correct information about the number of the people staying in the camp or registered equipment, we will be forced to charge you a fee in the amount of a 3-day stay for the unregistered person(s) and equipment.

GUEST CHECK-OUT

On your departure date you have to check-out till noon at the latest, otherwise you will have to pay for another overnight. You can also pay the accommodation, services and tourist tax costs one day prior to your departure after 3 p.m. For any services paid, you get a receipt.

USE OF A CAMPSITE

The choice of space in the camping area is free, except on numbered pitches, with the obligation of using the space rationally, taking care of your neighbours' space. Our staff will be happy to help you with that. On every campsite, you can set up only one caravan, camper van or tent and one vehicle of transportation (a car or a motorcycle). Any other vehicles have to be parked on the camp parking spaces.

Movable vehicles that you can sleep in (a camper van, a caravan) can have a side-tent attached to them only if the tent is attached to the vehicle's roof and it doesn't jut out. Switching a campsite is possible for a well-founded reason and only with the permission of a proper camp authority.

No outside visits are allowed in the camp without the permission of the reception staff.

The camp administration has the right to allow entrance for the visitors, walkers and issue them a short-term permit. It is prohibited to limit the space, so that free movement around the camp is made impossible.

Parking the vehicles on access roads and routes or temporary occupation of campsites, even if they are free, is strictly prohibited. Otherwise, you will have to pay an additional fee for the occupied space.

USE OF UTILITIES AND EQUIPMENT

You have to properly use electricity, sanitation facilities and camp equipment. Connecting and disconnecting the electricity is done by the guests themselves, the use of which you have to report upon your arrival. The electricity current is at 12A and 16 A; standard electricity outlets. Control of electric installations is performed by the campsite employee in charge.

Doing the dishes and laundry is permitted only in the designated rooms. Car washing is permitted only on the designated car wash location.

PETS

Dog owners are obligated to register their pets at the reception along with the proof of vaccination. Dog owners are obligated to keep their dogs on a leash, and to keep them tied at their space. Owners are obligated to clean up after their pets. Not following this rule is subject to fines.

PUBLIC ORDER AND PEACE IN CAMP

Please do not make noise which could disturb other guests, including the use of radios, televisions and musical instruments; peace and quiet periods in the campsite are from 11 PM to 7 AM. Not following this rule takes away the privilege of staying in the campsite

The speed limit for vehicles driving through the campsite is 10 km/h. Pedestrians in the campsite have the right of way over vehicles.

ENVIRONMENT PROTECTION

You are obliged to maintain order and cleanliness at your campsite, and protect the flora in the camp. Breaking, chopping and any other type of damaging the vegetation is prohibit

It is strictly forbidden to put nails in trees or any kind of damage of trees, taking gravel off the beach, fencing the space in which you are located or any kind of construction work on the selected place. Campsite management approves only standardised fences. Not following this rule takes away the privilege of staying in the campsite. Bonfires are forbidden by law because of fire hazard.

Guests are obligated to take care of the cleanliness of the space they are using. Leave used spaces in sanitary blocks the way you would like to see them when you arrive. Water is a natural gift; do not waste it! It is therefore strictly forbidden to make improper use of water, such as washing cars or other vehicles.

We are not responsible for loss of items from tents, caravans, campers. If you have found left or forgotten items, please bring them to the reception immediately.

The complaint book and the book of impressions is located at the campsite reception.

Guests who do not follow these house rules, as well as guests who, with their behaviour disturb the peace and quiet and other guests will not be able to use campsite accommodation services.
