

## HIŠNI RED KAMPA DANICA

### Spoštovani gosti, dobrodošli v našem kampu!

Veselimo se vašega obiska. Celotno osebje kampa se trudi zagotoviti, da bi bilo vaše bivanje pri nas čim lepše. Da pa bi bilo vaše bivanje lahko tudi brezskrbno, vas prosimo, da spoštujete naslednja pravila hišnega reda:

#### 1) PRIJAVA GOSTA

Prosimo vas, da se takoj po prihodu v kamp s svojim **osebnim dokumentom** (osebna izkaznica ali potni list) prijavite v recepciji kampa. Za šotor, avtodom ali prikolico prevzame gost kampa **tablico s številko**, ki jo je dolžan imeti na vidnem mestu vse do odhoda in jo ob odhodu tudi vrniti na recepcijo. **PRIJAVE GOSTOV SE OPRAVLJAJO OD 8. URE DALJE.**

Če se gosti oziroma osebe ne prijavijo, ravnajo v nasprotju s hišnim redom in bodo odstranjene iz kampa ter prijavljene pristojnim organom zaradi eventualne storitve prekrška zoper javni red in mir, motenja posesti, izogibanja plačilu turistične takse v primeru nočitve v kampu, izogibanja plačilu storitev kampa oziroma goljufije. Če se gost ne prijavi takoj ob prihodu ali če gost ob prijavi ne posreduje točnih podatkov o številu oseb in opremi, bomo prisiljeni zaračunati stroške v višini **tridnevnega bivanja** neprijavljenih oseb in opreme.

#### 2) ODJAVA GOSTA

**Na dan odhoda mora gost odjaviti najkasneje do 13.00 ure**, v nasprotnem primeru se gostu obračuna dodatna nočitev. Gost lahko plača bivanje, storitve in turistično pristojbino tudi dan pred odhodom po 15.00 uri. Za plačane storitve gost prejme račun.

#### 3) UPORABA PROSTORA ZA KAMPIRANJE

**Na neparceliranem delu** kampa je izbira mesta v kampu prosta, pri čemer morate racionalno uporabiti prostor in upoštevati prostor, ki ga zavzemajo sosedji.

**Na parceliranem delu kampa mora gost iti na mesto v kampu, ki mu ga določa tablica**, pri tem pa mu pomaga osebje kampa. Na vsaki parceli lahko gost postavi samo eno prikolico ali avtodom ali šotor in eno prevozno sredstvo (avto ali motor). Dodatno prevozno sredstvo je mogoče parkirati na parkirišču v kampu. Premična vozila za nočitev (avtodom ali prikolica) imajo lahko pred-šotore, če so naslonjeni na krov vozila, in ne smejo štrleti. **Sprememba izbranega mesta je mogoča samo izjemoma** zaradi opravičenega razloga in ob dovoljenju pristojne osebe kampa. V kampu je prepovedano sprejemati obiske neznanih oseb brez dovoljenja recepcije. Uprava kampa ima pravico dovoliti vhod obiskovalcem, sprehajalcem in jim izdati brezplačno kratkočasno dovoljenje. Prepovedano je omejiti prostor na način, da je onemogočeno prosto gibanje. Strogo je prepovedano parkiranje vozil na dovoznih cestah in poteh ali začasno zavzemanje drugih parcel ali mest, čeprav so prosta. V nasprotnem primeru bodo morali gostje plačati dodatno ceno za zasedeno mesto.

#### 4) UPORABA NAPRAV IN OPREME

Gosti kampa morajo pravilno uporabljati električne in komunalne naprave ter opremo. **Priključitve in izključitve električne energije opravljajo gostje sami, njihovo uporabo morajo prijaviti ob prihodu v recepciji.** Kontrolo varnosti električnih instalacij opravlja za to odgovoren delavec. Moč električne energije je 16 in 10 A, vtičnice so standardne.

Pomivanje posode in perila je dovoljeno v za to namenjenih prostorih. Pranje avtomobilov je dovoljeno na za to določenem mestu.

#### 5) ZAŠČITA OKOLJA

**Gosti kampa so dolžni vzdrževati red in čistočo na prostoru, kjer kampirajo, varovati nasade in zelenje, prepovedano je ograjevanje prostora ali katera koli gradbena dela na izbranem prostoru.** Prepovedano je lomljenje, sekanje ali poškodovanje rastlinja (zabijanje žebeljev, vezanje vrvic in podobno na drevesa). Prepovedano je izlivanje olje, gorivo, kipečo, slano in odpadno tekočino, kopati kanale in luknje na zemljišču, nekontrolirano izlivanje vode in puščati smeti zunaj obstoječih kontejnerjev. Za praznjenje kemičnega stranišča je določeno mesto v kampu. Smeti se zbirajo ločeno (plastika, papir, steklenice, ostali odpadki), odlagajo se v ustrezne kontejnerje za ločevanje odpadkov. **Pustite uporabljene prostore v sanitarnih blokih takšne, kakršne bi želeli najti. Goste kampa prosimo, da varčujejo z vodo.**

#### 6) JAVNI RED IN MIR V KAMPU

**Nočni mir v kampu traja od 23.00 do 7.00 ure.** V tem času ni dovoljeno gibanje z motornimi vozili, ukvarjanje s športom in rekreacijo, postavljanje in razstavljanje šotorov, uporaba radio naprave, televizorja in glasbenih instrumentov. Z neupoštevanjem te točke reda se odvzame možnost nadaljnega bivanja v kampu.

**Za vsa vozila je hitrost znotraj kampa omejena na 10 km/h. Pešci v kampu imajo prednost v primerjavi s prometnimi vozili.**

#### 7) OTROCI

**Odrasli gostje kampa so odgovorni za obnašanje svojih otrok in** ohranjanje miru. Otroci morajo biti pod nadzorom. Odrasli morajo plačati za škodo, ki jo povzroči mladoletna oseba. Otroško igrišče uporabljate na lastno odgovornost.

#### 8) DOMAČE ŽIVALI

**Živali so v kampu dovoljene, vendar ne smejo vznemirjati ostalih gostov kampa.**

Lastniki psov morajo imeti pse na povodcu in ustrezno privezane, da se zadržujejo samo na njihovem prostoru. Prav tako morajo počistiti vse iztrebke svojih hišnih ljubljencev. Za neupoštevanje teh navodil je zahtevana denarna kazen.

Hišni ljubljenci nimajo vstopa v toaletne prostore, na otroško igrišče in v ostale športne objekte (to ne velja za pse vodnike slepih oseb). Vsak lastnik je odgovoren za škodo, ki jo povzroči njegov hišni ljubljencek.

#### 9) POŽARNA VARNOST

**Kurjenje ognja na prostem, prinašanje lahko zažigajočih goriv, eksplozivnih naprav in podobno je zaradi nevarnosti pred požarom z zakonom prepovedano.** V primeru izbruha požara v kampu ali njegovi neposredni bližini ima gost obveznost pristopiti k organiziranemu gašenju.

#### 10) OSTALO

**Za svoje imetje in stvari v kampu je gost odgovoren sam.** Uprava kampa ne odgovarja za izgubljene, poškodovane ali ukradene predmete, ki so v lasti gostov. Prav tako ne odgovarja za poškodbe in nesreče gosta v kampu zaradi njegove nepazljivosti. Predmeti, ki so najdeni v kampu, se morajo izročiti recepciji zaradi vrnitve ugotovljenemu lastniku.

Knjiga pritožb in pohval je na voljo v recepciji.

Gostom, ki ne upoštevajo pravil hišnega reda, kot tudi gostom, ki s svojim vedenjem motijo mir in vznemirjajo druge goste, bo preklicana uporaba namestitvenih storitev.

## DANICA CAMPSITE CODE OF CONDUCT

### Dear guests, welcome to our campsite!

We look forward to welcoming you. The entire staff of the campsite is committed to making your stay with us as pleasant as possible. However, in order to make your stay carefree, we kindly ask you to respect the following house rules:

#### 1) GUEST CHECK-IN IS COMPULSORY

Please check in at the campsite reception immediately upon arrival with your ID (ID card or passport). For the tent, campervan or caravan, the guest must take a number plate from the campsite, which he/she must keep in a visible place until departure and return to the reception upon departure. CHECK-IN IS FROM 8:00.

If guests or persons fail to check in, they are in breach of the house rules and will be removed from the campsite and reported to the competent authorities for possible commission of an offence against public order, disturbing the property, evading the tourist tax in the case of overnight stays, evading payment for the campsite services or fraud. If the guest fails to check in immediately on arrival or if the guest fails to provide accurate information on the number of persons and equipment at check-in, they will be liable for charges equal to three days' stay of the unregistered persons and equipment.

#### 2) GUEST CHECK-OUT

On the day of departure, guests must check out by 13:00 at the latest, otherwise they will be charged an extra night. The guest can also pay the stay, services and tourist tax the day before departure after 15:00. The guest will receive an invoice for charged services.

#### 3) USE OF THE CAMPING AREA

On the unplotted part of the campsite, the choice of pitch is free and you must use the space rationally and take into account the space occupied by neighbours.

On the pitched part of the campsite, the guest must go to the pitch indicated on the sign and be assisted by the campsite staff. Only one caravan or motorhome or tent and one means of transport (car or motorbike) may be pitched on each pitch. An additional means of transport may be parked in the car park of the campsite. Mobile overnight accommodation vehicles (caravan or trailer) may have so-called entry tents, provided that they are leaning against the deck of the vehicle. The chosen pitch may be changed only exceptionally for a justified reason and with the authorisation of the person responsible for the campsite. It is forbidden to host third parties without the authorisation of reception. The campsite management has the right to allow visitors and walkers to enter and to issue them with a short-term permit free of charge. It is forbidden to restrict the space in such a way that free movement is prevented. It is strictly forbidden to park vehicles on access roads and paths or to temporarily occupy other pitches or spaces, even if they are vacant. Otherwise, guests will have to pay an additional price for the occupied space.

#### 4) USE OF FACILITIES AND EQUIPMENT

Guests must use the campsite's electrical and communal facilities and equipment properly. Electricity connections and disconnections are at the guests' own risk and must be declared at reception on arrival. The safety of the electrical installations is checked by the responsible employee. The power supply is 16 and 10 A and sockets are standard.

Dishwashing and washing machines are allowed in designated areas. Car washing is allowed in a designated area.

#### 5) ENVIRONMENTAL PROTECTION

Guests are obliged to keep the camping area clean and tidy, to protect the plantations and greenery, and not to fence the area or carry out any construction work in the chosen area. It is forbidden to break, cut or damage vegetation (nailing, stringing, etc.

to trees). It is forbidden to pour oil, fuel, bathing, salty or waste liquids, to dig canals and holes in the land, to pour water uncontrollably and to leave rubbish outside existing containers. There is a designated place on the campsite for emptying the chemical toilet. Garbage is collected separately (plastic, paper, bottles, other waste) and placed in the appropriate waste separation containers. Leave the used facilities in the sanitary blocks as you would like to find them. Guests of the campsite are kindly asked to conserve water.

#### 6) PUBLIC ORDER AT THE CAMPSITE

The night time peace in the campsite is from 23:00 to 07:00. During this time, no motorised vehicles, sports and recreational activities, setting up and dismantling of tents, use of radios, televisions and musical instruments are allowed. Failure to comply with this point of the rules shall result discontinuation of your stay at the campsite.

The speed limit for all vehicles within the campsite is 10 km/h. Pedestrians have priority over vehicles in the campsite.

#### 7) CHILDREN

Adult guests of the campsite are responsible for the behaviour of their children and for keeping the peace. Children must be supervised. Adults must pay for any damage caused by a minor. Use of the children's playground is at your own risk.

#### 8) PETS

Pets are allowed in the campsite but must not disturb other guests. Dog owners are required to keep their dogs on a lead and tied in their own area. They must also clean up any faeces left by their pets. Failure to comply with these instructions will result in a fine.

Pets are not allowed in the toilets, playground or other sports facilities (this does not apply to guide dogs for the blind). Each owner is responsible for any damage caused by their pet.

#### 9) FIRE SAFETY

The burning of fires in the open air, the bringing of combustible fuels, explosive devices, etc. is prohibited by law due to the risk of fire. In the event of a fire breaking out in the campsite or its immediate vicinity, the guest is obliged to join an organised fire-fighting operation.

#### 10) OTHER

The guest is responsible for his/her own property and belongings in the campsite. The campsite management is not responsible for lost, damaged or stolen items belonging to the guests. Neither is the campsite responsible for any injuries or accidents caused by the guest's carelessness. Items found at the campsite must be handed to reception for return to the identified owner.

A complaints and compliments book is available at reception.

Guests who do not respect the house rules, as well as guests whose behaviour disturbs the peace and other guests, will have their use of the accommodation cancelled.
